### **DELIVERY MODE(S):**

Online, paced learners must have access to a computer with a good internet connection.

### PREREQUISITE/COREQUISITE:

Learner must be a registered nurse (RN). Registered midwife or physician. Proof of registration is required.

#### **RESOURCE REQUIREMENTS:**

There are no required texts for this course. All required readings are available within the course.

### **CALENDAR DESCRIPTION:**

This course is designed for nurses who choose to specialize in sexual assault forensic nursing. Comprehensive specialized nursing care is addressed including trauma informed care supported with evidence informed strategies for support, evaluation, and intervention with victims of recent sexual assault. Learners will learn interview and examination strategies, injury identification, evidence collection, treatment



priorities, and how to support resilience and initial recovery. Learners will also understand legal and ethical issues related to sexual assault and understand issues related to documentation, reporting, legal reports and testimony. Key areas of course content are shown in the table below.

The content has been designed to meet the theory education requirements for the SANE-A (Sexual Assault Nurse Examiner of Adults/Adolescents) exams from the International Association of Forensic Nurses (IAFN). Nurses can work as examiners without the certification in some areas, but if they wish to certify after becoming clinically competent, they must have completed a theory course that meets the IAFN education requirements for SANE-A. The course also includes some pediatric content included in the course to address the needs of rural/northern communicates without specialized teams.

Although this is designed primarily in the Canadian context, some American and international legislation is discussed. The principles of the exam and evidence collection are relatively universal although specifics like the equipment used, and number of swabs may differ by jurisdictions.

#### **COURSE OBJECTIVES:**

- 1. To gain an understanding of the impact of sexual assault from a physical, psychological, and legal perspective.
- 2. To develop the skills required to appropriately interview, examine and collect evidence from victims of recent sexual assault.
- 3. To gain the skills required to improve care for sexual assault victims through appropriate, ethical, trauma-informed and evidence-based practice.

### **LEARNING OUTCOMES:**

Upon successful completion of this course, learners will be able to:

- 1. Describe the risk factors for sexual assault.
- 2. Discuss the roles of professionals involved in supporting victims of sexual assault and areas for collaboration, including trauma informed care.
- 3. Describe physical and psychological consequences of sexual assault for the victim and their family and the role of the SANE in reducing secondary traumatization.
- 4. Describe indicators of long-term consequences such as stress-related disorders.
- 5. Identify ethical issues in caring for sexual assault victims.
- 6. Describe methods to evaluate and improve care for sexual assault victims.





- 7. Identify key considerations and components in a non-forensic and a forensic sexual assault examination according to standardized guidelines.
- 8. Identify injuries and discuss their implications in sexual assault.
- 9. Discuss considerations for special populations such as male victims, samesex victims, disabled and elderly.
- 10. Describe techniques for collection and storage of evidence according to forensic standards.
- 11. Discuss issues related to consent, history taking and examination of sexual assault victims.
- 12. Describe cultural and socioeconomic factors which may impact an evaluation and treatment of victims.
- 13. Describe appropriate interventions for pregnancy and infection prophylaxis.
- 14. Identify potential methods to support victims in the acute phase after sexual assault including psychological first aid.
- 15. Differentiate burnout, compassion fatigue, and secondary traumatic stress including key considerations in self-care to reduce risks.
- 16. Discuss differences in fact vs. expert witness testimony related specifically to the sexual assault examiner.
