#### CALENDAR DESCRIPTION:

This course is designed to help students understand children's behavior and what it means to use a positive guidance approach in supporting children's social, emotional, and moral development. Environmental and developmental factors which influence behavior are examined, as are the principles of the guidance approach and ways in which these principles can be applied in early learning and child care settings.

**CREDIT/CONTACT HOURS:** 2 credits (30 hours)

**DELIVERY MODE(S):** Online Distance Delivery

**OBJECTIVES:** On completion of this course the student will be able to:

1. Explain how *guidance*, *discipline*, and *punishment* differ in goals and in practice.
2. Discuss legislative policies and ethical practices relevant to guiding children's behavior.
3. Explain how development influences behavior.
4. Identify environmental factors that can influence children's behavior.

5. Outline strategies practitioners can use to create positive interpersonal environments.
6. Identify positive and respectful communication practices and attitudes in guiding children’s behavior.
7. Discuss developmentally appropriate, positive prevention and intervention strategies when guiding children’s behavior.
