CALENDAR DESCRIPTION:

This course analyses the problems, the institutions and the changing roles in Canada since Confederation, and provides a base and some tools for inquiry into Canadian affairs.

CREDIT/CONTACT HOURS:

HI 2610 consists of three hours of lecture and discussion each week.

The course work includes lectures, discussions, research and writing assignments as well as a midterm and final exam.

- To develop and enhance historical research and synthesis skills as well as composition skills.

Work submitted more than ten days after the grace period will not be accepted for grading and students will receive a 0% for the assignment. Students will be assessed on their research, synthesis and writing in the course assignments. The presentation of information in terms of organization and writing will be given equal weight in grading to the research and analysis.

There will be a midterm exam scheduled during class in February and a final exam written during the exam period in April.
