CALENDAR DESCRIPTION:

A synoptic view of the Canadian legal system, with emphasis on underlying considerations of social policy. While considering the nature, sources, philosophy, and policy objectives of the law, selected topics from the fields of tort, and contract will be analyzed.

Some of the main areas touched upon include: the legal system, contract law, forms of business organization, land law, and torts and insurance.

- 1. To introduce students to basic legal concepts.
- 2. To familiarize students with specific areas in which law impacts business.
