## CALENDAR STATEMENT

NS1250 4 (2-0-2) 75 Hours 15 Weeks

### *Nursing Practice – Health Assessment & Nursing Process*

The focus is on the health assessment of the adult and expected health assessment findings throughout the lifespan. The course provides a beginning foundation of the nursing process as framework for developing assessment skills and use of clinical technologies necessary for determining client health status and provision of care. Course includes 15 clinical hours total.

**Prerequisites:** NS1500 and NS1205

**Corequisites:** MI1330 and NS1240

**Note:** Available only to Nursing students.

## COURSE HOURS/DELIVERY MODE(S)

All lecture and lab hours are face-to-face, supported by Moodle an online learning system. Clinical hours occur with an instructor present on the floor with the student.

Lecture: 2 hours/week

Lab: 2 hours/week

Clinical: 15 hours over 13 weeks

## COURSE OBJECTIVES

Upon completion of this course, the student must be able to:

1. Understand the role of health assessment in nursing practice and patient care in all settings.
2. Develop and demonstrate the relationship of health assessment and assessment skills in the nursing process through understanding of subjective and objective data collection, validation of findings, and exploration of beginning phases for patient care.
3. Provide rationale underlying for assessment techniques for subjective and objective data collection.
4. Apply therapeutic communication skills to facilitate professional relationship building, conducting health history interviews, health promotion activities, risk reduction identification, and patient learning.
5. Describe and demonstrate a holistic approach to health assessment across the lifespan.
6. Acquire the skills of physical examination and demonstrate safe, competent patient assessments.
7. Demonstrate professionalism and ethical practice during health assessment and nursing practice.
8. Demonstrate accurate, organized, concise documentation of health assessment findings.

## ASSIGNMENT DESCRIPTIONS

### 1) Lecture/Lab Pre-Quizzes: (10%)

The lecture pre-quizzes are completed on Moodle. These pre-quizzes will be multiple choice and completed by students individually on Moodle unless otherwise indicated. The content, timing, and frequency of the lecture quizzes are identified on the Moodle site for each week. Missed pre-quizzes will be assigned a score of zero. There will be no deferred or make-up quizzes. The average of all pre-quizzes will be worth 10% of the final grade. Quizzes are open-book.

### 2) Midterm Examination (30%)

The midterm exam will be administered over a 1-hour period. The exam will include content from lectures, required readings, and labs from Week 1 – Week 6 inclusive.

### 3) ~~Jigsaw Puzzle Critical Reflection~~ Functional Assessment Case Study (10%)

~~Students will participate in a Jigsaw Puzzle activity to collaboratively learn about health assessment and the older adult. Following the activity, students will individually write a critical reflection (word limit of 250) on their participation in the Jigsaw Puzzle Activity along with any resources that their group developed for the activity. Students will complete a Functional Assessment Case Study as a homework assignment following the class on Monday March 23<sup>rd</sup>, 2020. Students will submit a copy of the Functional Assessment Case~~

Study ~~is~~ critical reflection in Moodle for grading. Grading guideline located on Moodle will be based on the depth and breadth of the student's answering the questions of the case study. Students are to complete this case study individually.

#### 4) Final Examination (35%)

The final examination will be a computer based exam administered ~~over a 3.0 hour period~~ during exam week via GPRC's online learning platform Moodle, as per the Registrar's Schedule of exams. The content is ~~cumulative from midterm~~, and covers all lectures, required readings, and laboratory experiences. The exam will be composed of multiple choice, fill in the blank and possible matching questions. Accommodations will be granted if needed for students requesting changes in time or length of exam and at the instructor's discretion.

**Deferred final examinations** may be granted when an examination has been missed or interrupted because of illness, or a conflict with religious beliefs. In the case of illness (physical, mental or emotional), medical documentation will normally be required. See page 42 of the 2019/2020 GPRC calendar for further information.

#### 5) Clinical Practice (Clinical Assessment Tool) (15%)

A summative assessment of nursing practice will be completed by the student and the clinical instructor. This will be accomplished through observation, assessment and evaluation of the student during various clinical activities as well as the 3 Clinical Assessment Tool Activities students must complete during the clinical experience which are located on Moodle. Students will complete the Clinical Assessment Tool at the end of the semester and the instructor will also provide comments in this tool.

Students will receive ongoing verbal and/or written feedback from the clinical instructor throughout the course in order to support learning. Feedback may be supplemental with input from peers, the staff of an agency, and the client.

Students completed 2 (5) hour shifts for this course rather than 3. Students will be evaluated for the 15% on the 2 clinical days that were completed. Dates and times do not change to submit the Clinical Assessment Tool.

**Students must pass the Clinical Assessment Tool with a C+ in order to receive credit in NS 1250. Students who are absent from clinical days may be unable to meet the course objectives and will be unsuccessful in this course.**

Students at risk in any of the indicators on the Clinical Assessment Tool will develop a Learning Support Plan in collaboration with their Clinical Instructor. Students must successfully meet the Learning Support Plan by the agreed upon date. At final, students must achieve a "Pass" on all areas of the Clinical Assessment Tool in order to successfully complete NS1250. The Clinical Assessment Tool is on Moodle.

#### 6) SafeMedicate – Complete/Incomplete (April 13<sup>th</sup> – assessment open for 24 hours)

Students will complete a health numeracy assessment on-line through the SafeMedicate program. The assessment focuses on basic math skills to ensure success in the dosage calculation required in nursing. There is no grade associated with the assessment, but completion is required to proceed to 2<sup>nd</sup> year.



The assessment will be open for 24 hours starting at 0800 on April 13<sup>th</sup> until 0800 on April 14<sup>th</sup>. Once you have begun the assessment you have one hour to complete the questions. This program is used in all clinical practicums for the remainder of the nursing program. Information to purchase this program will be given in March 2020.

## LATE ASSIGNMENTS

It is expected that **ALL** assignments must be completed to obtain credit in the course. Assignments are expected to be passed in at the time and place they are due. Extensions may be granted and must be negotiated with the instructor prior to the due date and with a date specified for late submissions.

A penalty of one letter grade for each calendar day that an assignment is submitted after the due date will be deducted from the final mark. For example, a paper marked as an A, would receive an adjusted grade of A- if handed in one day late. When submitting assignments **electronically**, it is the **student's** responsibility to ensure the assignment has been received.
