CALENDAR DESCRIPTION:

An introduction to the concepts of innovation, health technology, systems thinking and relational leadership in a healthcare context. The course develops the knowledge, skills and values that foster personal capacity for innovation and relational leadership.

This course will be delivered on the GPRH HEC campus in a designated classroom as indicated on the student's timetable. Students are expected to attend classes in person.

COURSE OBJECTIVES:

Upon completion of this course, the student must be able to:

- 1. Integrate the core abilities of design thinking and innovation into their own practice and learning as nursing students.
- 2. Appreciate the usefulness of systems thinking in the design and delivery of healthcare.
- 3. Differentiate the attributes and practices of relational leadership from other leadership approaches used in healthcare today.
- 4. Explore the contributions and challenges of health technology in the design and delivery of healthcare.

5. Discover their own personal strengths and values that will support them to be leaders of innovation.

- 6. Relate the processes of design thinking and innovation to inter-professional practice and teamwork.
- 7. Apply the practices of relational leadership, design thinking, and innovation to address a realworld healthcare challenge.

LEARNING OUTCOMES:

- 1. Appraise leadership styles, own leadership abilities, and examine the practices of relational leadership as a style that is well-aligned with nursing
- 2. Identify opportunities in healthcare organizations and in population health to apply design thinking and discuss the process.
- 3. Explore different technologies in healthcare and link to innovation and leadership.
- 4. Identify opportunities for leadership in collaboration and discuss from various perspectives.

EVALUATION DESCRIPTIONS:

To pass NS 2005, students must complete all assignments and evaluation strategies.

Participation Rubric

Students are expected to attend and contribute to discussions during all classes and class activities. Individual student participation and contribution to group learning must be demonstrated during each class and throughout the course. Students are expected to be punctual, and prepared for classes, having completed the pre-readings as assigned. Students are expected to use professional language, be respectful to others in the class and consistently demonstrate professional behaviors. In keeping with professional behavior, students are asked to report any absences to the course instructor prior to the scheduled class. Unexplained absences without informing the instructor prior to class and not contributing to class and group discussion will result in a failure on the participation rubric. Leadership Reflection Assignment

Leadership is important in all aspects of nursing. Effective nurse leadership practices help create healthy workplace environments and improve patient experiences and outcomes. It is essential for all nurses and nursing students to embrace opportunities to develop their leadership skills.

Assignment Description - Part 1 Video Clip:

As part of a discussion posting on the NS2005 myClass site, students are to find and include a short video clip (2-4 minutes) from a movie or TV show demonstrating the qualities of a positive or negative relationship between a leader and a follower and answer the questions below.

Some ideas for movie or TV video clips include Greys Anatomy, Call the Midwife, The Good Doctor, ER, New Amsterdam, House, movies, and so many others...be creative in your search!

The following assignment criteria must be met:

- 1) Describe the leadership style that was depicted in the video clip that you chose. Provide your rationale.
- 2) Was the leader in the video clip a formal leader or an informal leader?
- 3) Describe the leadership qualities (good or bad) that were demonstrated in the video clip that you chose.
- 4) Describe the potential consequences (good or bad) of the leadership qualities in the clip you have chosen.
- 5) What do you believe are the ideal characteristics and qualities that a leader should have? List a minimum of 3-4 qualities and be specific.
- 6) What do you believe are the ideal characteristics and qualities that a follower should have? List a minimum of 3-4 qualities and be specific.
- 7) As a student nurse, provide two (2) examples you can do to demonstrate leadership.

Video clip discussion posts should be well articulated and composed of complete and grammatically accurate sentences with no abbreviations. Discussion posts should be a minimum of 350 words and a maximum of 500 words, size 12 font. Students must use professional language and include 2-3 references. Direct quotes should be avoided. Students are expected to add value to their discussion posts by paraphrasing and including their own thoughts, perspectives, and insights. APA formatting is expected however, students may use a first-person narrative.

Assignment Description and Criteria - Part 2 Discussion Responses:

Students will also be expected to respond to two (2) discussion posts from other students in the class. Discussion posts should be well articulated and composed of complete and grammatically accurate sentences with no abbreviations. Students must use professional language and responses should be 150-250 words, size 12 font. APA formatting is expected however, students may use a first-person narrative.

Response postings should be thoughtful and include the student's personal perspectives and insights. Response postings should also be related to the student's prior knowledge, work or personal experiences, and course readings. Avoid postings that are limited to 'I agree' or 'great idea', and so on. If you agree (or disagree) with a posting, then explain *why you agree/disagree* by supporting your statement(s) with concepts from the literature or by including a related example or experience.

It is expected that ALL discussion posts are respectful and polite. Confrontational or argumentative posts must be avoided and will result in a grade of zero.

Group Project Assignment

Collaboration is an essential component in the nursing profession. Collaboration as a nurse requires using the best ideas and work towards the best outcomes. Group projects require students to work together and collaborate with one another. Collaborative working groups are particularly helpful as individuals often have limited areas of expertise and can benefit from others' input, insight, experiences, and perspectives. Collaboration is an effective strategy for problem solving and leads to innovation, increased success, and improved communication.

Assignment Description - Group Project:

Students are to collaborate with their assigned group members to develop a PowerPoint presentation teaching tool that addresses a health promotion topic from the list below. Students will create their project and use language suitable for a target audience of children aged 10-12 years old. Health promotion topics will be assigned to each group by the course instructor. It is expected that all members of the group collaborate and equally develop and create the project.

Completed group projects will be presented to other students in the class as determined and scheduled by the course instructor. All members of the group must equally present their project to their peers and class members. A 5–10-minute question period will follow each group project presentation and all members of the group should be knowledgeable regarding their assigned health promotion topic and prepared to answer peer and instructor questions.

Group Project Presentation Schedule: (Note: The schedule project presentation classes are subject to change):

A3-April 5 -April 12th B3-March 31-April 10th C3-April 4 - April 11th

It is an expectation that completed PowerPoint projects will be emailed to the course instructor by the due date specified on the course outline. Academic dishonesty of any kind on the project will not be tolerated and will result in a grade of zero.

The following project assignment criteria must be met:

- 1. The focus of the PowerPoint presentation must be related to the assigned health promotion topic.
- 2. PowerPoint presentations must include accurate and credible information, with breadth and depth, appropriate to the target audience of 10–12-year-old children.
- 3. Projects should include an introduction, conclusion, title slide and a slide for references.
- 4. The PowerPoint presentation can be up to a maximum of eighteen (18) slides including both title slide and the references slide.
- 5. The assigned topics will be one of the following:
 - a. Cannabis (marijuana)
 - b. Alcohol
 - c. Effects of sugar in junk food
 - d. Effects of salt in junk food
 - e. Bullying
 - f. Vaping
 - g. Social media
 - h. Promoting self-esteem
 - i. Coping strategies
 - j. Self-harm
- 6. Each group member must be an active participant in the creation of the PowerPoint presentation group project.
- 7. Students must be creative and innovative in their project design and use of technology and outside-the-box thinking.

- 8. PowerPoint slides should be colorful and use images/pictures.
- 9. Language used must be age appropriate and avoid slang terminology and abbreviations. Font size should be legible, clear, and easy to read.
- 10. Ensure the PowerPoint presentation is age appropriate, demonstrates a health promotion focus, and catches the attention of the target audience.
- 11. APA formatted references are required. Use relevant, credible, and current sources for this project. Paraphrasing is strongly encouraged, and direct quotes should be avoided.
- 12. Grades will be assigned as per the Group Project Presentation Rubric.

The Group Project Presentation Grading Rubric has been attached to the course outline and posted on the NS2005 myClass site.

Group Project Peer Participation Evaluation

Students will complete the Peer Evaluation for Group Work Participation document provided to evaluate the participation and collaborative behaviour of their group members. The participation evaluation scores from each of the student's group members will be combined to provide a grade. The Peer Evaluation for Group Work Participation document has been attached to the course outline and has been posted on the NS2005 myClass site.

Comprehensive Final Exam

The final exam is a comprehensive exam including concepts and content covered throughout the course. Students are encouraged to prepare for this exam throughout the semester. The exam will be completed on myClass. This exam will include a variety of question formats including but not limited to, multiple-choice questions and multi-select questions. This exam will cover nursing knowledge from the course concepts, assigned readings and course activities. This exam will evaluate the student's knowledge, problem-solving, and critical thinking.

This exam will be completed in person during exam week (April 14-24) as scheduled by NWP. Instructions regarding exam location, completion, format, and proctoring will be provided to the students in advance and will be posted on the NS2005 myClass online site prior to the exam. This exam will be completed within scheduled and allotted time limits as determined by the course instructor(s). Students are expected to complete the exam individually. Academic dishonesty of any kind on this exam will not be tolerated and will result in a grade of zero.

A student who has missed a final exam because of incapacitating mental and/or physical illness or other extenuating circumstances must provide a notice of absence and a physician's sick note when applicable. A minimum of 12 hours prior to the exam, students are required to contact their course instructor(s) and request a deferred final exam. A designated date and time for the deferred exam will be determined by the course instructor(s).
