3320 MINUTES OF DECEMBER 7, 2006

3321 ATHLETIC ELIGIBILITY STANDARDS POLICY

Academic Council received the Athletic Eligibility Standards Policy for approval.

MOVED by D. Brown, seconded by D. Hart, the Athletic Eligibility Standards Policy be accepted, as presented.

It was clarified that a GPA of 1.0 is a passing grade which is standard at Colleges² and Universities across Canada.

3322 INSTRUCTOR EMERITUS

The honourary designation of Instructor Emeritus is awarded by Grande Prairie Regional College to retired faculty members in recognition of meritorious services. To be eligible, faculty members must have at least 15 years of tenured instructional service and have left full time employment with the College. Instructors achieving this distinction are encouraged to display their continuing affiliation with the College in various ways: research, community service and publications.

3323 MEDICAL EDUCATION IN GRANDE PRAIRIE

Mr. Evans Forsyth, a member of the College Board of Governors was invited to speak to Academic Council about recent activities concerning medical education in Grande Prairie. He reported that there is a joint board consisting of the

College Board (GPRC) and Peace Country Health Board (PCH) to look into the educational needs of Peace Country Health and how GPRC can be of assistance. Discussions are at the early stage. The coordination between the two Boards, the two Institutions and future opportunities of a possible three way collaboration between PCH, GPRC and an appropriate University was outlined.

3324 QUALITY ASSURANCE: ONLINE AND BLENDED COURSE DESIGN POLICY

Academic Council received the Quality Assurance: Online and Blended Course Design Policy for approval.

MOVED by J. Stiles, seconded by L. Nock, the Online and Blended Course Design Policy be accepted as presented.

Moved by D. Brown, seconded by D. Hart to amend the motion to delete the words "credit and non credit" from Item 1 of the Procedures/Rules Statement. **Amendment to main motion CARRIED**

The intent of the motion is that the policy deals with credit courses only.

Moved by D. Brown, seconded by D. Fedeyko to table the main motion. **DEFEATED (9/6)**

CARRIED

It was suggested that quality assessment standards for non credit courses be discussed at the February meeting.

3325 DEGREE ACCESS – COLLABORATIONS VS. DEGREE GRANTING

The College is currently involved in nine collaborative degrees. The College was given authority to grant degrees in January 2005 but have yet to apply for one. We are currently negotiating a B.A. and B.Sc. with Athabasca University. The pros and cons of degree completion versus degree granting were reviewed. It was suggested that this discussion item be added to the February agenda.
