Mr. Finlay reported that the approved recommendations of the Ad-Hoc Waitlist Committee were followed to eliminate wait lists. Students provided positive feedback to the new process. The Departments that monitor their class size closely also felt it was a success. The Committee is recommending that the procedures be followed again with better communication between chairs and the advisors. It is hoped that the Chairs are making plans for over-enrolled sections for the winter semester. There is a contingency fund available to finance opening new sections for over-enrolled classes.

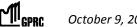

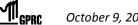
