# 3196 CALL TO ORDER

# 3197 AGENDA

MOVED by Mr.Fedeyko, seconded by Mr. Dion the agenda be approved. CARRIED

The Chair determined that a quorum was present. He outlined the process required to revise the Authority and Bylaws of Council.

### 3198 ACADEMIC COUNCIL AUTHORITY AND BYLAWS

MOVED by Mr. Brown, seconded by Dr. Lee that:

Whereas revisions to the Academic Council Authorities and Bylaws were approved as per the motion of October 14, 2005 due to changes in the Statutes of Alberta from the "Colleges Act" to the "Post-Secondary Learning Act" (effective as of March 18, 2004), and;

Whereas changes to the Collective Agreement (August 14, 2003 -August 13, 2006) between the Academic Staff Association and the Board of Governors necessitated revision of the Academic Council Authority and Bylaws;

Therefore, the Academic Council Authority and Bylaws Review Committee recommend to Academic Council acceptance of the amendments as presented excluding the statement in Item 1(b) "(if in compliance with section 46)"; and;

And also, revision of the numbering necessitated by the deletion of Item 7.

#### CARRIED

**Moved** by Dr. Deimert, and seconded by Dr. Ramaswamy to split the initially proposed motion so that changes to Item 1 are voted on separately. **DEFEATED** 

**Moved** by Dr. Demerit, seconded by Dr. Lee to amend the initially proposed motion to change the preamble in Item 4 "Academic Policies must be recommended by Academic Council to the Board of Governors for approval." to read "Academic policies must receive Council approval first, but do not become effective without Board approval."

### DEFEATED

**Moved** by Dr. Deimert seconded by Dr. Lee to include as a preamble to Item 4:

"The mandate of Academic Council is to provide a forum for College constituents to debate ideas and concepts leading to the development of Academic Policies. In addition to policy development and review, Academic Council monitors the implementation of Academic Policies, recommending the future direction of College programming, and identifying significant trends in education and society and their implications for the College. Academic policies must be reviewed by Academic Council before receiving approval by the Board of Governors."
