3253 ACADEMIC ISSUES

Blended Learning

A workshop on blended learning, held during Reading Week, has spawned interest in blended learning course development. GPRC has one course that is fully developed for blended learning. Once the workshop format is solidified information will be distributed.

U of A meeting

Our college is actively pursuing degree completion opportunities. There are a number of options available to GPRC. In February, GPRC hosted a meeting with the U of A. Their central administration was very supportive of degree completion opportunities in Grande Prairie. Data base access was discussed. The College is seeking to make a presentation at the U of A Deans' Council to pursue this item.

Hospitality & Tourism

The Department of Business Administration is pursuing development of a Hospitality & Tourism Management diploma program. There are other such programs at institutions with smaller catchment areas than the college. An industry advisory committee has been formed. The department is still working on the second year courses with industry partners. The program is being built around the national tourism standards. It was noted that some Ecampus online courses may fit into this initiative. The goal is to launch in this program next year. This is a new two year program rather an a fourth major in the current Business Administration diploma.

Pharmacy Assistant - Retail

SAIT and GPRC have entered into an agreement to offer a five month Pharmacy Assistant – Retail program to students in the north. The projected initial intake is for this spring.

Pre Employment Cooking

GPRC is collaboration with NAIT on a 12-week Pre Employment Cooking program to bring to this area filling a need for trained and skilled works. The



projected start date for this program is June. The four weeks of practicum hours contribute to apprenticeship requirements.

3254 OPEN DISCUSSION

There has been a position paper tabled by the Agriculture ministry – the rural presidents will meet with the authors of this strategy paper.

There was support expressed for the new initiatives.

The Students' Association reported \$4.5 billion is being put into an endowment for Post Secondary education.

Notice of motion that the SA will be looking at the Academic Grievance policy.

Circle of Aboriginal students are planning an "Honour the Graduate" on April 9th.

GED writing dates are offered in May and June.

The speaker at the Teachers Convention was thought provoking.
