#### **CURRICULUM COMMITTEE**

## Discussion:

- There are several issues with the current format for Curriculum Committee:
  - Scheduling with TAE faculty is very difficult
  - Information for academic credit programming is not relevant to most of the TAE faculty just as TAE programming is not relevant to faculty in the Schools of Health, Wellness and Career Studies (HWCS) and Arts, Science and Upgrading (ASU) faculty.
  - TAE Curriculum meetings will be held in FV with VC to GP as necessary.
- Curriculum Committee membership for faculty will be split by schools; TAE will be one group, HWCS and ASU will be the other (see attached committee membership).
  - Faculty may choose to attend both meetings, but this will not affect quorum.

- Faculty will have the option of voting on items presented, regardless of which meeting they attend.

  - VP Academics and Research
  - Deans
