3280 ACADEMIC COUNCIL MEMBERSHIP

New members were welcomed.

Due to a change in the management of the College and the fact that Administration has been appointed to Council by position title, Mr. Doug Hart will be Acting President. An Acting Vice President Academic will be appointed monthly. Dr. Erlendson is the Acting Vice President, Academic for the month of September.

The complete slate of student representatives will not be known until after the Students' Association elections in October.

3281 ESTABLISHMENT OF MEETING DATES AND TIMES

As per the terms of reference, Academic Councils meets the second Thursday of each month during the academic year. The second Thursday in November of 2006 is November 9th, the day before Fall Session break when there are no classes and Administrative Offices are closed. It is noted that the November meeting is the last meeting where curriculum changes for 2007/08 would be considered for inclusion into the calendar. It is proposed that the November meeting date be changed to November 16, 2006.

Ongoing faculty development

Feedback indicates that this new model was very successful and it is recommended that it be continued.

A province wide faculty development initiative is being developed. Ms. Korpan has agreed to be the College's representative.
