EVALUATION DESCRIPTIONS:

1. Journal Reflections

In this journal reflection assignment, nursing students are expected to engage in an exploration of their clinical experiences each week based on provided prompts. This reflective practice aims to enhance self-awareness, critical thinking, and the integration of theoretical knowledge into practical situations. There will be a total of 5 journal entries. Due dates will be listed on the calendar posted on D2L. **Having 2 or more journal reflections graded as a “Fail” will result in failure of this course.**

2. Clinical Research

Students will be expected to complete thorough patient research prior to clinical shifts. Research will be submitted to their instructor for review and evaluation. **Having 2 or more clinical research assignments graded as a “Fail” will result in failure of this course.**

3. Practicum Evaluation Tool (pass/fail)

****Students must receive the level of Progressing (P) or Satisfactory (S) in all sections of the PET (Practicum Evaluation Tool) to pass the clinical course.**

A formative assessment of nursing practice will be completed by the student and instructor midway and at the end of the course. This will be accomplished through observation, assessment, and evaluation of the student in various activities in the clinical setting. Feedback may be supplemented with input from peers, faculty and staff at the clinical site, and the clients/families.

The instructor will provide the students with a summative written final evaluation at the end of the course.

At midterm students who are at risk for failing or receive an Unsatisfactory (U) rating on any section of the PET will develop a Learning Support Plan in collaboration with the clinical instructor. Students must successfully meet the requirements of the Learning Support Plan by the agreed upon date. **At final, students must achieve a level of Progressing (P) or Satisfactory (S) in all areas of the PET to successfully complete NP2100.**

Clinical Practice Preparation

Professional responsibility for nursing students includes clinical practice preparation related to evidence-informed practice and patient safety. Preparation includes appropriate understanding, synthesis, an integration of relevant knowledge. The clinical instructor, in conjunction with the clinical site, will identify appropriate time frames for students to assess patient records.

To be adequately prepared for clinical experiences, students will participate in activities outside of their scheduled clinical course hours. Activities can include the following: specific clinical patient preparation, clinical site orientation, medication systems orientation, patient health record review and review of textbook and relevant evidence-informed articles.

clinical practice preparation is required in addition to direct course hours. Students who are not adequately prepared to provide safe and competent patient care will not participate in clinical activities.
