CALENDAR DESCRIPTION:

This practicum provides students with the opportunity to integrate their knowledge, skills, and values in a professional early learning setting. Students apply developmentally appropriate practices, design engaging environments, and demonstrate leadership in supporting children's play, learning, and well-being. Practicum experiences may take one of several forms, including facilitating outdoor and nature-based play environments, operating a student-led preschool program, or completing a supervised workplace practicum in a licensed early learning and child care setting. Students work collaboratively with peers and mentors, engage in reflective practice, and demonstrate professional conduct aligned with Flight: Alberta's Early Learning and Care Framework and the Code of Ethics for Early Childhood Educators.

PREREQUISITE(S):

All first and second-year courses in the Early Learning and Child Care Diploma program and a standard first aid certificate or consent of the Department.

(Students must successfully complete CD2020 immediately prior to taking CD2145.)

REQUIRED TEXT/RESOURCE MATERIALS:

On-campus, in person.

Lecture, discussion, small group work and video taping of the student's interactions with young children.

LEARNING OUTCOMES:

Upon successful completion of this practicum, the student will be able to complete all duties and responsibilities of a Level Three Child Care Educator, specifically they will:

- Develop a positive rapport with children and interact with children in a nurturing, supportive manner.
- Demonstrate the ability to effectively guide children's behavior.
- Demonstrate an awareness of the nutritional, health, and safety needs of young children.
- Demonstrate an understanding of emergent curriculum by providing materials and experiences which are based on a variety of factors including their observations and reflections of children's developmental needs, interests, and interactions in a play based environment.
- Demonstrate the ability to participate in children's play to support, facilitate, and/or extend the play using appropriate strategies or interventions.
- Demonstrate professional behavior.
- Establish and maintain collaborative working relationships with other adults in the workplace setting.
- Establish and maintain open, friendly, and informative relationships with each child's family.
