**CALENDAR DESCRIPTION:**

This course in mental health provides opportunities to acquire knowledge, skills, and attitudes to promote wellness through safe, ethical nursing practice in a variety of contexts. The focus will be on mental well-being throughout the lifespan. Learning experiences will provide students with an understanding of the mental health nursing process. The clinical hours listed are the total number of hours and will be offered over 6 weeks. Note: Available only to Nursing students.

#### **Safemedicate Modules Examinations:**

Year 3 students enrolled in NS 3270 will be tested on the following:

- Essential Skills
- Body Surface
- IV Therapy

Students who do not achieve 90% in any of the tested modules will be required to re-write the exam for that module. Students will have three opportunities to achieve 90% on all Safemedicate module exams. If a student is not able to achieve 90% after the third attempt, they will not be able to attend the clinical course and may be asked to withdraw from the program. If a student returns to the nursing program after a program interruption, and a different medication calculation program has been instituted, the student will be responsible for purchasing the new program and writing the medication math calculation exam that is currently being used.

#### **Suicide Prevention, Risk Assessment, and Management (SPRAM) Modules:**

SPRAM is an eLearning series consisting of 9 modules that respond to the foundational learning needs of health practitioners working in Addiction and Mental Health (AMH). The content supports developing foundational competence in suicide prevention, risk assessment, and managing individuals at-risk for suicide. The SPRAM is accessed through your AHS MyLearningLink. This is a pass/ fail component. Upon completion, submit a copy to the drop box on myClass.

#### **Knowledge Checks:**

Students will complete timed, open-book quizzes on myClass every week on topics covered in the course. The purpose of the knowledge checks is to reinforce key concepts, encourage timely engagement with course readings, and promote active learning. The quizzes will provide immediate feedback to students on their understanding of the material and highlight areas for further study.

#### **Journaling Assignment:**

Students will complete a journaling assignment designed to promote self-reflection, critical thinking, and professional growth. Through reflective writing, students will process their experiences, link theory to practice, and evaluate their use of therapeutic communication and interventions. Journaling provides a structured opportunity for students to explore their emotional responses, consider ethical and professional issues, and identify areas for ongoing development. This process supports deeper learning, enhances clinical reasoning, and fosters the self-awareness necessary for effective mental health nursing practice.

#### **Student-Led Simulation Assignment:**

The purpose of the student-led simulation assignment is to provide nursing students with an opportunity to integrate theoretical knowledge with clinical skills through the development and facilitation of realistic, evidence-informed mental health scenarios. This assignment fosters critical thinking, clinical judgment, communication, and collaboration while enhancing students' confidence and competence in conducting mental health assessments, applying therapeutic communication techniques, and reflecting on professional practice within a safe and supportive learning environment.

The assignment is divided into three parts:

#### **Part A: Student-Led Simulation: Teaching Plan (Group Assignment)**

With a partner (ideally from the same clinical group), students will design a mental health simulation focused on a specific mental health or substance use disorder. Each pair of students will complete and submit a Student-Led Simulation: Teaching Plan Template (posted on myClass) together. The teaching plan will outline the learning objectives for the student-led simulation, the patient's mental health diagnosis and clinical focus, the patient's profile and presenting situation, the scene setup, the patient's role, the nurse's role, and prebriefing. Both students in each pair will receive the same grade for the Student-Led Simulation Teaching Plan.

**Note:** After completing the teaching plan, each pair of students will need to record themselves acting out the simulation. The students' recording will need to demonstrate the components outlined in the teaching plan. The recordings will be reviewed during the lab to allow students to critique and reflect on each pair's simulation scenario.

### **Part B: Student-Led Simulation: Self-Reflection**

After developing and participating in the student-led simulation, each student will **independently** complete a Student-Led Simulation: Self-Reflection (posted on myClass). The self-reflection will support emotional insight, clinical growth, and ongoing development of therapeutic communication and professional presence.

### **Part C: Peer Critique & Reflection**

Students will have the opportunity to review their peers' simulation recordings and will complete a Peer Critique and Reflection (posted on myClass) for each. The peer critique and reflection will focus on identifying effective strategies used during the simulation and areas for improvement, and lessons gained from observing others engage in therapeutic mental health care.

### **Final Exam:**

Students will complete a two-hour final exam that assesses all major topics covered in the course. Student absences from the exam will be graded as zero. A physician's note will be required for absences due to illness. A student who has missed a final exam because of incapacitating mental and/or physical illness or other extenuating circumstances must provide a notice of absence and a physician's sick note when applicable. ### **Clinical Assessment Tool (CAT):**

Evaluations of the student's clinical performance will be completed using the clinical assessment tool (CAT) (posted on myClass). Students will be required to complete and submit a self-assessment using the CAT, on specified dates, along with examples of how they met the requirements for each of the domains from clinical practice. At midterm, the student will complete the midterm sections, providing 2-3 examples of how they are meeting each competency or how they will continue to work on meeting the competency. A formative and written CAT will be completed by the clinical instructor and provided to the student at the end of the course.

A pass on the Clinical Assessment Tool (CAT) requires the student to demonstrate competence and achievement of a PASS in each of the six domains. A FAIL on any part of the Clinical Assessment Tool (CAT) will result in a course failure.

#### Elsevier Adaptive Quizzing (EAQ) Modules:

Adaptive quizzes using the Elsevier platform are utilized throughout the BScN Program. Modules specific to mental health have been assigned at the *Intermediate Mastery* level. This is to increase knowledge, identify gaps in knowledge, and become adept at this testing method, which is used to access professional registration post-graduation. The modules will open on the course start date and the course code to register will be posted on myClass.

**Note:** Students who have completed the modules specific to mental health assigned for this course, and have reached an *Intermediate Master* level, will be required to complete a minimum of 50 questions for each module.

#### REQUIRED CLINICAL EXPERIENCES:

Students must achieve a PASS on the Clinical Assessment Tool (CAT) to pass the course.

#### Clinical Practice Preparation:

Professional responsibility for nursing students includes clinical practice preparation related to evidence-informed practice and patient safety. Preparation includes appropriate understanding, synthesis, and integration of relevant knowledge. To be adequately prepared for clinical experiences, students will participate in activities outside of their scheduled clinical course hours. Activities can include specific clinical patient preparation, clinical site orientation, and review of the textbook and relevant articles. Clinical practice preparation is required in addition to direct course hours. Students who are not adequately prepared to provide safe and competent patient care will not participate in clinical activities. Being unprepared for clinical practice demonstrates unprofessional behavior and will be reflected in the student's clinical assessment.

Professional responsibility for nursing students also includes clinical shifts. **All clinical absences must be reported to their clinical instructor AND the clinical agency prior to the commencement of the clinical shift. Students are responsible to consult with their clinical instructor to make up for missed clinical shifts.** Unexplained clinical absences demonstrate unprofessional behavior and will be reflected in the student's clinical assessment and may put the student at risk for failure.

#### Clinical Practice:

Clinical practice will take place in agencies dealing with mental health and/or addiction issues in acute care psychiatric settings. In the event of an **unavoidable absence**, students are **required to notify the clinical instructor and clinical site as soon as possible**.

##### Acute Care Psychiatry (Unit 11):

- The student will be directly supervised by a clinical instructor and will collaborate with the multi-disciplinary team in consultation with the instructor to learn and practice the art of caring for individuals with acute variances in mental health.

- The student is responsible for reviewing the Mental Status Examination (MSE) and mental health disorders, along with relevant nursing management and psychotherapeutics.
- Alberta Health Services (AHS) and NWP identification must always be worn. The dress code is modest casual wear that aligns with the AHS dress code. Blue jeans, tight pants, shorts, exposed midriffs, and open-toed shoes are not permitted.

#### **Detoxification Unit (Northern Addictions Centre):**

- The student will be directly supervised by a clinical instructor and will collaborate with the multi-disciplinary team in consultation with the instructor to learn and practice the art of caring for individuals with acute variances in mental health who have a history of substance use.
- The student is responsible for reviewing the Mental Status Examination (MSE), the Open Education Resource document available on MyClass, common mental health disorders, the trauma-informed toolkit, and familiarize yourself with therapeutic communication and harm reduction principles.
- Alberta Health Services (AHS) and NWP identification must always be worn. Do not wear a tag with your last name displayed. The dress code is NWP scrubs as per NWP BScN Student handbook dress code for clinical attire.

#### **Course Material and Announcements:**

The NWP Faculty of Nursing creates a myClass site for all undergraduate nursing courses. #### **Assignment Policy:**

ALL assignments, examinations, and quizzes weighted 10% or greater must be completed to obtain credit in the course and be permitted to write the final examination if applicable. Students are expected to make every effort to complete assignments on time. Assignment submissions are expected on the date determined by faculty. If extensions are necessary, they may be requested up to 48 hours prior to the assignment due date and should be submitted in writing to the faculty member involved. Not all extensions will be granted. In exceptional situations, extension requests within the 48-hour period may be considered. Late assignments will have 5% of total marks (or one letter grade) for the assignment deducted for each day/partial day (including weekend days) beyond the due time. For example, a paper marked at B+ would receive an adjusted grade of B if handed in one day late. After 5 days, a grade of 0

will be awarded to the assignment. If the late penalty places the grade below the necessary pass grade, students will be unsuccessful in the course. When submitting assignments electronically, it is the student's responsibility to ensure the assignment has been received. Papers/assignments may not be rewritten for a higher grade. Concerns regarding grading are to be discussed with the faculty member involved. All evaluation components of the course must be completed PRIOR TO being permitted to write the final exam.
