COURSE DESCRIPTION: This course will provide students with an introduction to the practical field of early childhood development and education. Students will observe and participate in a variety of children's programs and will contrast the similarities and differences between environments, program practices and services provided for children and their families. Students will participate in all routines of each program that they visit and **may be** encouraged to bring in simple activities to implement with the children, i.e. reading a book, or a simple art experience. Students will attend an on-campus weekly seminar.

Note: students with credit in CD 1040 and CD 1060 will not receive credit for CD 1045

REQUIRED TEXT: TBA

CLASS FORMAT: Classes will be comprised of program visits and observations, information sessions, professional development activities and discussion about professional practice.

COURSE OBJECTIVES:

- 1. The learner will demonstrate an understanding of program options for young children and their families.
- 2. The learner will identify, compare and contrast a variety of early childhood programs available for young children (includes a comparison of schedules and routines).
- 3. The student will draw on other course content to make increasingly more complex observations and analysis of the programs that are visited. The learner will gain the ability to thoughtfully examine practices in the early childhood field and relate them to course learning and the principles of developmentally appropriate practice.
- 4. The learner will begin to gain an understanding of children's growth and development.
- 5. The learner will begin to understand differences in approaches to child guidance, child development and curriculum planning and implementation.

GRADING POLICIES:

The Credit/No Credit grading system is used to determine the final course grade. Attendance is mandatory and students must successfully fulfill all observation and seminar requirements in order to receive credit in this course.

ATTENDANCE POLICIES:

Students **must** attend all of the program visits. You will be required to make up visits that are missed.

Students **must** attend all seminars. You will be responsible for demonstrating knowledge of any seminar material that you miss.

*If students miss more than two program visits the instructor has the right to require students to withdraw from practicum

- 1. Due Dates: Due dates for any written submissions and other course requirements will be specified in writing by the instructor.
