CALENDAR DESCRIPTION: This course is designed to help students understand children's behaviour and what it means to use a positive guidance approach in supporting children's social, emotional, and moral development. Environmental and developmental factors which influence behaviour are examined, as are the principles of the guidance approach and ways in which these principles can be applied in early learning and child care settings

COURSE OBJECTIVES:

- Research the importance and significance of developing positive relationships with children.
- Explain what guidance is
- Summarize factors which influence the behavior of children
- Apply course knowledge in the area of the building blocks of guidance. Gain an understanding in the areas of: how behavior communicates, how temperament affects interactions with children and how development influences behavior.
- Explain the suggested guidance strategies and demonstrate an understanding of these strategies.

- Explain how guidance, discipline, and punishment differ in goals and in practice.
- Discuss legislative policies and ethical practices relevant to guiding children's behavior.
- Explain how development influences behavior.
- Identify environmental factors that can influence children's behavior.
- Outline strategies practitioners can use to create positive interpersonal environments. -
- Identify positive and respectful communication practices and attitudes in guiding children's behavior.
- Discuss developmentally appropriate, positive prevention strategies when guiding children's behavior.
