CALENDAR DESCRIPTION:

Students will attend weekly seminars throughout the semester in preparation and support of this practicum. Students will design and operate an eight week program for preschool children. With the support of program instructors, students will be responsible for all aspects of a program for young children and their families.

DELIVERY MODE(S): Lecture, discussion, small group work and video taping of the student's interactions with young children.

Learning Outcomes:

- 1) To build a positive rapport with young children.
- 2) To interact with children in a nurturing and supportive manner.
- 3) To utilize a positive approach to setting and maintaining limits.
- 4) To support children in their development of autonomy and initiative.
- 5) To insure the nutritional health, and safety needs of young children.
- 6) To facilitate, extend and enrich children's play in a variety of curriculum areas.
- 7) To establish and maintain a physical environment for young children which is aesthetically pleasing and developmentally appropriate.
- 8) To demonstrate the use of the physical environments as the third teacher.
- 9) To plan curriculum that supports children's development in all areas.
- 10) To plan, implement and evaluate experiences, learning centres and group times.
- 11) To communicate effectively and work collaboratively with other adults in the programme.
- 12) To communicate effectively and develop a positive relationship with the parents in the program.
- 13) To demonstrate professional behavior in regard to attendance, punctuality, confidentiality, and dress
- 14) To demonstrate competence in assessing his/her professional strengths and the ability to identify areas for professional growth.

OBJECTIVES:

- 1) Students will attend weekly seminars throughout the semester to prepare, develop and construct a plan to support this final practicum.
- 2) Students will design and operate an eight week programme for preschool children.
- 3) With the support of the programme instructors, students will be responsible for the implementation as well as all other aspects of a programme for young children and their families
