**CALENDAR DESCRIPTION:** This course uses the study of various intellectual, cultural, and historical manifestations to provide students with a window into the French world.

**PREREQUISITE(S)/COREQUISITE:** FR 2120 or equivalent or consent of the Department

**REQUIRED TEXT/RESOURCE MATERIALS:** Le Guide vert Michelin Paris and supplementary readings

**DELIVERY MODE(S):** This course is offered as a travel study course on site in Paris or at an alternative Francophone venue. Students can expect additional expenses for travel and accommodation.

#### **COURSE OBJECTIVES:**

• The aim of this course is to enable students to develop a fundamental knowledge and understanding of the significance and value of the elements

of history, art, literature, music, politics, architecture, cuisine and language, integral to French culture.

**LEARNING OUTCOMES:** After successful completion of this course, students will be able to...

- observe, assess, and understand the varied aspects that have contributed and continue to contribute to the learned set of beliefs, values, and norms that comprise French culture.
- demonstrate a basic knowledge of varied facts of French culture and understand the richness, interrelatedness, complexity, and evolution of aspects that contribute to French culture.
- write objectively on the significance and value of the aspects that contribute to the beliefs, values, and norms that define French culture.
- speak competently in French on a topic of personal interest pertinent to French culture.
- demonstrate an appreciation of French culture.
