# **REQUIRED TEXT/RESOURCE MATERIALS:**

J.L. Granatstein and N. Hillmer, Empire to Umpire: Canada and the World to the 21st Century, 2nd Edition.

#### **CALENDAR DESCRIPTION:**

In general, this course examines Canada's diplomatic, political and cultural interrelationship with its two great mentors - Great Britain and the United States. More specifically, discussions will focus on the development of Canadian foreign policy (from Laurier to Mulroney) with particular emphasis on Canada's middle power role in global affairs during the Cold War period. Notes: Some background in Canadian history is recommended.

# **CREDIT/CONTACT HOURS:**

HI 4550 consists of three hours of lecture and discussion each week.

# **DELIVERY MODE(S):**

The course work includes lectures, discussions, research and writing assignments as well as a midterm and final exam.

#### **OBJECTIVES:**

The primary objectives of HI4550 are:

- To present students with an overview of Canada's role in the world since 1867.
- To develop and enhance historical research and synthesis skills as well as composition skills.

Students will be granted five (5) days of extension to use at their discretion during the term. They may be applied to any of the three assignments in any combination (ie. submitting one assignment three days late, another two days late and the third one time). Extensions beyond this will only be considered when students contact the instructor <u>prior</u> to the deadline and present evidence of extenuating circumstances. Other scheduled coursework will not be considered an extenuating circumstance.
