CALENDAR DESCRIPTION: This course covers the gas metal arc welding (GMAW), flux core arc welding (FCAW), metal-cored arc welding (MCAW) and submerged arc welding (SAW) theory components of Alberta Apprenticeship Welder Training, 1st period. Topics include: power source feeders, filler metals, shielding gas, troubleshooting and maintenance.
