**CALENDAR DESCRIPTION:** This course covers the gas metal arc welding (GMAW), flux core arc welding (FCAW), and submerged arc welding (SAW) theory components of Alberta Apprenticeship Welder Training, 1<sup>st</sup> period. Topics include: power source, wire drive systems, shielding gas, regulator flow meters, wire classification and maintenance.
