## Course Evaluation

Each chapter summary must be handed in the next class following the class that chapter is covered. NO CHAPTER SUMMARIES WILL BE ACCEPTED LATE, without a written explanation of just cause for the delay. The Instructor will be the judge of just cause in all instances.
- 17% Classroom participation. Each student will lose 1% for each hour of class that is missed without a written explanation of just cause.
- 10% Midterm exam. This will consist of 100 multiple choice questions on chapters 1-18. Students will have 45 minutes to complete it.
- 10% Research paper #1. Due Feb. 2 by 6 pm. Research papers will not be accepted late without written explanation of just cause.
- 10% Research paper #2. Due March 2

Research Paper Guidelines

You are to pick a topic that interests you and write on some of the legal implications of that topic. Each research paper must be 3-5 pages long and use at least 3 research sources. Each one will be marked on the following basis:

1% - introduction

2% - spelling

2% - grammar

4% - content

1% - conclusion

25% Final exam. 200 multiple choice questions on Chapters 1-34. It will be written in the gym and students will have 2 hours to complete it. The multiple choice questions (but not the choices for the five possible answers) for the midterm and the final exams will be put on reserve in the library about a week before the exam. You are encouraged to discuss the questions amongst yourselves or to set up study groups to prepare answers. All questions will come directly from the text or the guest speakers. The correct answer will not be what is "true" or "just" or what can be justified but what the text says.
