CALENDAR DESCRIPTION: Private study of guitar or a non-principal instrument. This is a two-term course offered over fall/winter terms. It is identifiable in the Schedule of Courses (Timetable) with a Part A and a Part B. Students must register in both the Part A and the Part B of all types of sections offered (sections, labs, seminars, etc.) for this course.

PREREQUISITE/COREQUISITE: Royal Conservatory Level 8 Theory, Conservatory Canada Gr. 4, or MU1000

REQUIRED TEXT/RESOURCE MATERIALS:

There are no required texts for this course. I will create a course pack based on the learning needs of the student.

DELIVERY MODE(S): Remote Studio Lesson

COURSE OBJECTIVES: This course is designed to give students the necessary skills to develop fluency on the guitar in jazz and popular styles. Students will study technique and repertoire designed to enable them to perform in a variety of musical situations.

LEARNING OUTCOMES: Upon completing this course, students will:

- Be able to find notes in all positions on the fretboard by engaging in a variety of reading exercises
- Apply jazz harmonic and melodic techniques in performance
- Perform accompaniment and soloing techniques in blues, jazz, rock, and country
- Develop the discipline to practice/improve on a daily basis
- Develop their ability to perform music at a high level through discussion and practical application of phrasing, articulation, and expression
