CALENDAR DESCRIPTION: A study of musical thought from classical Greek civilization and a historical survey of music from Medieval Period through the Renaissance. Students will be introduced to the musical terminology and concepts of the periods under study. They will develop skills of aural recognition, writing, research methods, and correct bibliographic practices. This course is intended for B.Mus. and B. Ed. Music majors and minors.

CREDIT/CONTACT HOURS: 3 (3-0-0) UT 45 Hours

DELIVERY MODE(S): Lecture

OBJECTIVES (OPTIONAL): The purpose of the course is to provide an overview of the period of music history from antiquity to 1600 in terms of the evolution of musical style and its social and political context. The study of Western European music history will begin with plainchant and continue through the music of the Renaissance. Research techniques, formatting, and term paper writing will be taught as part of the course. As this is an introductory course, class time will be allotted for instruction in library research and term paper formatting. At the end of the course, students will develop the skills necessary to identify both aurally and in written form the various styles and genres of the music history eras.
