CALENDAR DESCRIPTION: This course will involve a balanced coverage and critical analysis of both male and female issues. Material will be drawn from empirical research and conceptual discussions surrounding gender and gender roles. Examples of topics include the impact of stereotypes of masculinity and femininity, and gender in relation to power relations, mental health, intelligence, sexuality, violence, and caregiving. Are men and women really all that different? If so, how significant are the differences? Implications of similarities and differences will be discussed.

PREREQUISITE(S)/COREQUISITE: PY1040. Students transferring to UNBC must also present successful completion of PY 1050 as a prerequisite to this course.

REQUIRED TEXT/RESOURCE MATERIALS: Required: Gender: Psychological Perspectives (7th edition) by Linda Brannon. **Choice of:** Missoula: Rape and the Justice System in a College Town by Jon Krakauer or I am Malala by Malala Yousafzai

DELIVERY MODE: The course work includes lectures, class discussions, in-class group and individual work.

COURSE OBJECTIVES: Students will be taught the history and current research methods into gender studies as well as the contemporary theories of gender identity and development. The sex/gender differences into various psychological processes such as intelligence, emotion and sexuality will also be explored. Other topics that will be covered will be the effects gender has on one's experiences in school, at work, and on one's physical and psychological well-being.

LEARNING OUTCOMES: As a result of taking this course students will have an appreciation of the complexity of factors (biological, social and psychological) that contribute to their conception of being a gendered person. Students will also be able to identity how being gendered affects their thinking, behaviour and emotions, as well how it influences their health, relationships, school and work lives.

Exams can consist of multiple-choice, short and long answer questions. Exact details will be given to you later in the term regarding each specific exam structure. Students are not permitted to leave the exam room once the exam has started until the exam has been completed and turned in. All electronic devices are prohibited from use at any time during exams. All exam marks are final. This means you cannot rewrite an exam because of a poor grade and there are no extra assignments to make up for a poor exam grade. For the final exam students will have two hours from the start time to complete the exam.

The assignment must be word-processed. It is important to save a copy of any written work handed in for credit or grading. Details on the assignment will be given to you on a separate handout at the beginning of the term. Assignments are due on the date set by the instructor at the beginning of class in hardcopy-paper format. Do not print double-sided. The instructor does NOT accept emailed assignments. Unauthorized late assignments will have a 5% per day late penalty applied to the assigned grade (including weekend days). If there is a valid reason for an extension, it must be requested in person prior to the due date although students should be advised that extensions are rarely granted in lieu of the late penalty.
